Review Report by the Chairman on Board`s Overall

As required under code of Corporate Governance, an annual evaluation of the Board of Directors of (the "Board") of SG Power Limited (the "Company") is carried out. The purpose of this evaluation is to ensure that the Board`s overall performance and effectiveness is measured and bench marked against expectations in the context of objectives set for the Company. Areas where improvements are required are dully considered and actions plans are framed.

The Board has recently completed its annual self-evaluation for the year ended June 30, 2025 and I report that:

The overall performance of the Board measured on the basis of approved criteria for the year was satisfactory. The overall assessment as Satisfactory is based on an evaluation of the following integral components, which have a direct bearing on Board`s role in achievement of Company`s objectives:

I am pleased to present the chairperson review report of the Company for the year ended June 30, 2025. This year was full of challenges for the Board of Directors. In addition to uncertain gas supply, the gas rates were revised many times and also RLNG rate was revised upward making generation cost more expensive than K. Electric cost. Our Generation cost has substantially gone up keeping in view the day to day maintenance expenses, higher fuel costs and salaries of technical staff.

As a result our associate Company SG Allied Businesses Ltd is now buying minimum power from Our Company and relies on K. Electric supplying power which is now cheaper.

1. Vision, mission and values: Board members are familiar write the current vision, mission and values and support them. The Board revisits the mission and vision statement from time to time.
2. Engagement in strategic planning: Board has a clear understanding of the stake holders (Shareholders, customers, employees, vendors, Society at large) whom Company serves. The Board has a strategic vision of how the organization should be evolving over the next three to five years. Further Board sets annual goals and targets for the management in all major performance areas.
3. Diligence: The Board members diligently performed their duties and thoroughly reviewed, discussed and approved Business Strategies, Corporate Objectives, and Plans, budgets, financial statements and other reports. It received clear and succinct agendas and supporting written material in sufficient time prior to board and committee meetings. The board met frequently enough to adequately discharge its responsibilities.
4. Monitoring of organization`s business activities. The Board remained updated with respect to achievement of Company`s objectives, goals, strategies and financial performance through regular presentations by the management, internal and external auditors and other independent consultants. The Board provided appropriate direction and oversight on a timely basis.
5. Diversity and Mix: The Board members effectively bring the diversity to the Board and constitute a mix of independent and non-executive directors. The non-executive directors and independent directors were equally involved in important board decisions.

DIRECTOR'S REPORT

The Board of Directors of SG Power Limited is pleased to present 32nd Annual Report and Audited Financial Statements of the Company together with Directors Report and Auditors Report thereon for the year ended June 30, 2025 .

S.G Power Limited is a public limited company incorporated in Pakistan on February 10, 1994, under the repealed companies Ordinance, 1984 (repealed with the enactment of the Companies Act, 2017). The shares of the company are listed on Pakistan Stock Exchange Limited.

The auditors have given an observation regarding the existence of material un-certainty regarding Company's ability to continue as a going concern. The directors do not agree with this observation although the Company has made huge loss in this year but it is because of administrative expenses occurred during the year therefore the loss as at June 30, 2025 stood at **Rs. -8.40 million** (2024 profit 1.667 million) and accumulated loss at June 30, 2025 stood at **Rs. 266.778 million** (2024 Rs. 258.373 million). These conditions do not indicate the existence of a material uncertainty but administrative expenses occurred during the year may cast significant doubt on Company's ability to continue as a going concern and, therefore, it may be unable to realize its assets and discharge its liabilities in the normal course of business. Another ground for reservation is that associated company SG Allied Business Limited only bought a limited quantity in last year as compared to previous year due to Cost of power generation is becoming more expensive because of ever rising Natural Gas rates.

FINANCIAL RESULTS

The performance of the company during the Year ended June 30, 2025 account under review has been on turmoil. The Company has reported the loss in current period as business activities of SG Power Limited is declining, the demand of electricity from sister concern is lower as compared to previous year. That is why the company sales has declined to **Rs. 6,145,860/-** as compared to previous year's sale of **Rs. 17,302,191/-**.

The generation cost has substantially gone down to **Rs. 7,931, 978/-** due to decrease in sales but administrative & Selling Expenses and has gone up to **Rs. 6,615,074/-** as compared to previous year. The accumulated loss have increased to **Rs. 266,778,180/-**.

ایس جی پاور لمیٹڈ ایک پبلک لمیٹڈ کمپنی ہے جو پاکستان میں 10 فروری 1994 کو منسوخ شدہ کمپنیز آرڈیننس، 1984 (کمپنیز ایکٹ، 2017 کے نفاذ کے ساتھ منسوخ) کے تحت قائم کی گئی تھی۔ کمپنی کے حصص پاکستان اسٹاک ایکسچینج لمیٹڈ میں درج ہیں۔

آڈیٹرز نے کمپنی کے جاری رہنے کی قابلیت کے حوالے سے مادی غیر یقینی صورتحال کے بارے میں مشاہدہ کیا اور مشاہدہ کیا ہے۔ ڈائریکٹرز اس مشاہدے سے متفق نہیں ہیں حالانکہ کمپنی نے اس سال میں بہت زیادہ نقصان کیا ہے لیکن یہ سال کے دوران ہونے والے انتظامی اخراجات کی وجہ سے ہے اس لیے 30 جون 2025 تک خسارہ روپے تھا۔ 8.40 ملین (2024 منافع 1.667 ملین) اور 30 جون 2025 کو جمع شدہ نقصان روپے رہا۔ 266.778 ملین (2024 روپے 258.373 ملین)۔ یہ شرائط کسی مادی غیر یقینی صورتحال کی موجودگی کی نشاندہی نہیں کرتی ہیں لیکن سال کے دوران ہونے والے انتظامی اخراجات کمپنی کی جاری تشویش کے طور پر جاری رکھنے کی صلاحیت پر ابہم شکوک پیدا کر سکتے ہیں اور اس وجہ سے، یہ اپنے اثاثوں کا ادراک کرنے اور کاروبار کے معمول میں اپنی ذمہ داریوں کو ادا کرنے سے قاصر ہو سکتی ہے۔ ریزرویشن کے لیے ایک اور بنیاد یہ ہے کہ متعلقہ کمپنی ایس جی الائیڈ بزنس لمیٹڈ نے پچھلے سال کے مقابلے میں صرف ایک محدود مقدار میں خریدا ہے کیونکہ قدرتی گیس کے بڑھتے ہوئے نرخوں کی وجہ سے بجلی کی پیداوار کی لاگت مزید مہنگی ہوتی جا رہی ہے۔

بدقسمتی سے گیس کے نرخوں میں مسلسل اضافے نے K کے مقابلے میں بجلی کی پیداوار کو بہت غیر اقتصادی بنا دیا ہے۔ کمپنی کی طرف سے پیدا کی جانے والی بجلی 1.6 گنا زیادہ ہے۔ ایس جی پاور لمیٹڈ کا واحد صارف ایس جی الائیڈ بزنس لمیٹڈ ہے جو صرف K. الیکٹرک کے بند ہونے کی صورت میں بجلی خریدتا ہے اور اس دوران کمپنی کو کریسٹن اسٹار انشورنس لمیٹڈ کی جانب سے 51% حصص حاصل کرنے کے لیے سود کی پیشکش موصول ہوئی ہے۔ بدقسمتی سے بجلی کی پیداوار پچھلے سال کے مقابلے میں بہت کم ہے کیونکہ بجلی پیدا کرنا غیر اقتصادی تھا۔

مالیاتی نتائج

30 جون 2025 کو ختم ہونے والے سال کے دوران کمپنی کی کارکردگی ہنگامہ خیز رہی۔ کمپنی نے موجودہ مدت میں نقصان کی اطلاع دی ہے کیونکہ ایس جی پاور لمیٹڈ کی کاروباری سرگرمیاں کم ہو رہی ہیں، بہن تشویش سے بجلی کی مانگ پچھلے سال کے مقابلے میں کم ہے۔ یہی وجہ ہے کہ کمپنی کی فروخت کم ہو کر روپے 6,145,860/- تک پہنچ گئی ہے۔ پچھلے سال کی فروخت Rs 17,302,191 کے مقابلے میں ۔

پیداواری لاگت کافی حد تک کم ہو کر روپے تک پہنچ گئی ہے۔ فروخت میں کمی لیکن انتظامی اور فروخت کے اخراجات کی وجہ سے 7,931,978/- روپے تک پہنچ گئے ہیں۔ پچھلے سال کے مقابلے میں 6,615,074/- جمع شدہ نقصان بڑھ کر روپے ہو گیا ہے۔ 266,778,180/-

REPORT ON THE AUDIT OF THE FINANCIAL STATEMENTS

Opinion

We have audited the annexed financial statements of **S.G. Power Limited** (the Company), which comprise the statement of financial position as at **June 30, 2025**, the statement of profit or loss and other comprehensive income, the statement of changes in equity, the statement of cash flows for the year then ended, and notes to the financial statements, including a summary of material accounting policies and other explanatory information, and we state that we have obtained all the information and explanations which, to the best of our knowledge and belief, were necessary for the purpose of audit.

In our opinion and to the best of our information and according to the explanations given to us, the statement of financial position, statement of profit or loss and other comprehensive income, statement of changes in equity and statement of cashflows together with the notes forming part thereof conform with the accounting and reporting standards as applicable in Pakistan and give the information required by the Companies Act, 2017 (XIX of 2017), in the manner so required and respectively give a true and fair view of the state of the Company's affairs as at June 30, 2025, and of the loss, other comprehensive loss, the changes in equity and its cash flows for the year then ended.

Basis for Opinion

We conducted our audit in accordance with International Standards on Auditing (ISAs) as applicable in Pakistan. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are independent of the Company in accordance with the International Ethics Standards Board for Accountants' Code of Ethics for Professional Accountants as adopted by the Institute of Chartered Accountants of Pakistan (the Code) and we have fulfilled our other ethical responsibilities in accordance with the Code. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Material Uncertainty Related to Going Concern

We draw attention to note 1.2 in the financial statements, which indicates that the Company's accumulated loss as at June 30, 2025, stood at Rs. 266.632 million (2024 loss: 258.373 million) and the current liabilities exceeded the current assets by Rs. 10.605 million (June 30, 2024: Rs. 2.804 million). These conditions indicate the existence of material uncertainty that may cast significant doubt about the Company's ability to continue as a going concern and, therefore, it may be unable to realize its assets and discharge its liabilities in the normal course of business.

The management of the company is planning for an alternative source for generating low-cost electricity and is confident in generating profits in future to discharge its liabilities. The management of the Company has prepared these financial statements on a going concern basis as disclosed in note 1.2 to the financial statements. Our opinion is not modified in respect of this matter.

Emphasis of Matters

We draw attention to note 1.3 to the financial statements, which states that a material non-adjusting event occurred after the year ended June 30, 2025. The Crescent Star Insurance Limited has acquired 6,785,236 ordinary shares, approximately 38.05% of the issued and paid-up capital of the Company. The transaction occurred and completed after the financial year end and disclosed as a material non-adjusting subsequent event in accordance with IAS 10 "Events after the Reporting Period".

Key Audit Matters

Key audit matters are those matters that, in our professional judgment, were of most significance in our audit of the financial statements of the current period. These matters were addressed in the context of our audit of the financial statements as a whole and, in forming our opinion thereon, we do not provide a separate opinion on these matters.

1.2	Going concern		
	The Company has accumulated losses as at June 30, 2025 of Rs.266.632 million (June 30,2024: Rs.258.373 million). The current liabilities exceeded from the current assets by Rs. 10.605 million (June 30, 2024 : Rs. 2.804 million). These conditions indicates the existence of a material uncertainty that may cast significant doubt on Company's ability to continue as a going concern and therefore, it may be unable to realize its assets and discharge its liabilities in the normal course of business. The Company has not been able to generate profits from its operations due to the extraordinary increase in gas tariffs, which has rendered the cost of electricity generation uncompetitive. Management is actively evaluating alternative sources of electricity generation, including solar energy, with the aim of reducing production costs. Management is confident that by adopting low-cost energy sources, the Company will be able to achieve sustainable profitability in the future. Furthermore, the Directors and the associated company have committed to provide financial support and liquidity to the Company as and when required. Accordingly, management has prepared these financial statements on the basis of the going concern assumption in accordance with IAS 1 "Presentation of Financial Statements.		
1.3	Events after Reporting Period, Non Adjusting Event - Disinvestment of Shareholding		
	Subsequent to the year ended June 30,2025, the shareholders of S.G. Power Limited (the company) entered into a Share Purchase Agreement dated 13 August 2025 with the Crescent Star Insurance Limited (the Acquirer) for the dis-investment of there shareholding in the Company. Under this agreement, Crecent Star Insurance Company acquired 6,785,236 ordinary shares, approximately 38.05% of the issued and paid-up capital of the Company. The public announcement was made on August 13, 2025 in accordance with the provisions of the Securities Act 2015 and the Listed Companies (Substantial Acquisition of Voting Shares and Takeovers) Regulations 2017. The total consideration under the agreement was PKR 45.662 million which is PKR 6/- per ordinary share. The transaction occured and completed after the financial year end, and disclosed as a material non-adjusting subsequent event in accordance with IAS 10 "Events after the Reporting Period". <i>sumo</i>
